Meeting Minutes for Annual Board Meeting, October 3, 2024, 7:00pm Meeting held at the Lakewood United Church of Christ, 100 Carr St., Lakewood, CO 80226

- Approximately 30 residents were in attendance in addition to Board Members and District 30 candidates

### **Treasurer's Report**

- Substantiallythrough the budget year; revenues and expenses are largely on track
  - Currently projecting to come inapproximately \$200 under planned revenue
  - o 111 paid memberships to, goal was 150, slightly down from previous years
    - Note that online payments are now enabled, but the majority elect to pay by cash or check
    - Approximately 250 households have been members in the past three years; board is working on getting the word out
    - We hand out in excess of 1,000 newsletters, so it is (and always has been) an small percentage of household that elect to be members
  - o MLCA did receive a 2nd grant from City of Lakewood
  - Newsletter advertisements are helping bring in more revenue
  - Expenses are tracking very close to budget
  - Chris negotiated a lower price for tree lighting Thanks Chris!
- Community Discussion Following Treasurer's Report
  - Regarding lower membership, residents raised concerns that they are noticing more rentals and even Air BnB/VRBO (even though these are not permitted by law)
  - Question regarding IRS status of MLCA: MLCA is not (and cannot legally be) a 501(c) organization
  - Comment from residents that it was encouraging to see many young families at the summer bbq
  - Comment from the audience resident has lived in Lakewood since 2018 and has never heard of MLCA

- Question about whether anything is happening at the school that impacts MLCA
  - School is doing great, Principal is well-respected and many families are optioning in
  - School is working to improve traffic and parking
    - Feedback is welcome on this issue
- Question about whether the school or even the church would be willing to help us advertise
  - We partner on events such as the movie night, we'll have a booth at the Fall festival

#### **Amendments to MLCA Bylaws**

- Bylaws are available for review on the MLCA website (<u>www.mlca.webador.com</u>), and five printed copies were available for review at the meeting
- Proposed changes summarized as:
  - Changing "he" to "they" throughout the document
  - Changing allowable maximum number of board members from 9 to 11
  - At last Year's Annual Meeting, residents approved a change of the MLCA boundaries, and the bylaws are being amended to reflect that change
- Motion to approve as summarized made and seconded by residents in attendance
  - Discussion:
    - Is the number capped? The proposed amendment would increase the cap to 11 with quorum still based on simple majority
- Vote was called and Motion passed with 20 Affirmative, 0 opposed, and 0 Abstaining
